ISSUE UNDER SECTION 708A(5)(e)

New Issue of Shares: Notice pursuant to s708A of the Corporations Act (the Act)

As announced on 6 April 2016, Stonewall Resources Limited (the **Company**) has issued 46,500,000 fully paid ordinary shares in the Company to sophisticated investors at an issue price of \$0.01 per share under the Company's 15% placement capacity pursuant to ASX Listing Rule 7.1. In addition to this, the Company issued 121,052,632 fully paid ordinary shares in the Company to sophisticated investors pursuant to shareholder approval granted at the General Meeting of shareholders held 23 February 2016.


The securities issued are part of a class of securities quoted on the Australian Stock Exchange Limited (**ASX**).
