
**ISSUE OF SHARES & APPENDIX 3B**

The directors of Stonewall Resources Limited (**Stonewall or Company**) wish to announce that pursuant to shareholder approval of Resolution 2 granted at the Company's General Meeting held on 17 August 2015, the Company has issued 133,333,333 shares to Smart Vision Investment Group Ltd (a nominee of Hanhong New Energy Holdings Ltd).

In addition, the Company has issued 11,111,111 shares to an unrelated sophisticated investor at an issue price of \$0.009 raising a total of \$100,000.00 which will be used to assist with the Company's general working capital requirements including those of its South African subsidiary, Stonewall Mining Pty Ltd. These shares will be issued under the Company's 15% placement capacity in accordance with ASX Listing Rule 7.1.


